To Kill Flies and Ticks on Cattle

Dilute concentrate with water prior to application.

- Quart dilution: Mix 1.5 fluid ounces of concentrate with 1 quart of water.
- Gallon dilution: Mix 6 fluid ounces of concentrate with 1 gallon of water.

Apply using a pressure sprayer to thoroughly wet the animal's coat. Product may also be applied by tank dipping.

- May also be applied through custom dairy spray systems calibrated to deliver the equivalent of 6 fluid ounces of concentrate per gallon of water.
- Ensure spray equipment is properly calibrated to thoroughly wet the animal's coat without excessive runoff.

Repeat treatment at intervals of 5 to 12 days, or as reinfestation warrants.

Do not directly spray cattle feed, food, or water sources.

To Kill Flies and Ticks in Cattle Areas

Dilute concentrate with water prior to application.

- Quart dilution: Mix 1.5 fluid ounces of concentrate with 1 quart of water.
- Gallon dilution: Mix 6 fluid ounces of concentrate with 1 gallon of water.

Apply using a pressure sprayer to areas around cattle, barns, and other locations where flies and ticks may congregate or emerge at the rate of 1,000 sq. ft. per gallon of solution. Repeat as reinfestation warrants.
